[*] Must provide proof of legal residence outside of Wilkes County by providing a **DRIVERS LICENSE**. **Rates are based on current dues structure. Rates can change at the approval of The Board and Membership** Membership fees are billed **in advance the 1st of each month for the following month**. Fees shall be due and payable on the first day of the month following the month in which the statement is issued. For example, if the statement date is October 1st, fees are due November 1st. Fees shall become delinquent 30 days after becoming due and payable if still unpaid. **A late fee of \$25.00 will be added for each 30 days past due.** After due notice of indebtedness and a request to pay has been given to any member, and the account of said member becomes delinquent as defined above, the Board shall have the power to suspend or terminate the membership of said member.
